## COURSE DESCRIPTION

Deceptive Behavioral Detection 2.0 is a structured 10-hour training program designed to provide law enforcement officers with practical skills for assessing verbal and non-verbal behavioral indicators during roadside encounters and interviews. This course integrates behavioral science principles, cultural awareness, and operational experience to support informed investigative decision-making. Students will examine how stress responses influence communication, how contextual factors affect behavior, and how observable deviations from established baselines may inform investigative assessments. Instruction explores the phases of communication commonly associated with deception—preparation, delivery, response, and follow-up—and emphasizes recognizing behavioral patterns and inconsistencies rather than relying on single cues. The course is taught by Nick Jackson, an experienced interdiction instructor with over 14 years of law enforcement service, including a decade focused on narcotics and criminal interdiction. His instruction is grounded in professional experience and established legal standards, providing officers with structured frameworks for linking observed behavior to reasonable suspicion and probable cause consistent with constitutional requirements.

## KEY TRAINING POINTS

- Recognizing verbal and non-verbal behavioral indicators
- Establishing baselines and identifying observable deviations
- Understanding stress-related behaviors and contextual influences
- Distinguishing nervous behavior from indicators requiring further inquiry
- Identifying inconsistencies in travel narratives
- Linking behavioral observations to reasonable suspicion and probable cause
- Articulating observations clearly in reports and testimony reports and testimony

Students will analyze structured case studies, participate in scenario-based interview exercises, and practice articulating behavioral observations for reports and testimony. The course is designed to strengthen investigative reasoning and professional articulation while reinforcing constitutional standards and ethical policing practices.
